PUBLIC EXHIBITION AGREEMENT

DATE: March 9, 2023

This public exhibition agreement (the "Agreement") is made by and between:

DR. LEOMAR C. MIANO Southern Luzon State University (SLSU) (Exhibitor)

and

ROMAE CHANICE MARQUEZ COO EDUKSINE PRODUCTIONS CORPORATION

Screening Dates: March 31, 2023

1. Exhibition Permission.

EDUKSINE PRODUCTIONS CORPORATION hereby grant Exhibitors permission to screen the film, "Bagahe" online and for public viewing on the above mentioned dates.

2. Exhibition Format and Equipment.

EDUKSINE PRODUCTIONS CORPORATION will be providing up to 2,000 tickets to each of the films open to the whole Philippines, for the Exhibitor's use which will be given when the payment has been transferred. In any event that the payment will be late, EdukSine will wait for the payment and will coordinate with the Exhibitor's office, and still provide the tickets as long as this agreement is signed.

Exhibitors shall be responsible for all equipment and testing of the link in their equipment. Confidentiality and security of the movie file and promotional materials is highly encouraged. The film's online link shall be deleted after one day from the last screening date.

3. Exhibition Fee.

Exhibitors must pay an amount of PHP 55,000 face to face screenings. All expenses for the event such as electricity, equipment, promotional materials and food and other expenses shall be shouldered by the Exhibitors. The fee can be paid at least 2 weeks AFTER the screening through cash, check or can be deposited through:

4. Photography and Publicity Release.

Exhibitors are permitted to photograph before and after the screenings of the film online and may use all such photographs for reference and marketing purposes. The taking of videos by the audience during screenings is not allowed.

EDUKSINE PRODUCTIONS CORPORATION shall not be connected in any way to whatever agreement the Exhibitors will sign with another company or establishment, which will serve as its sponsor.

5. Intellectual Property and Anti-Camcording Law

Exhibitors acknowledges and agrees that i) films are protected by Philippine and International Copyright Laws; ii) Republic Act (RA)10088 also known as the Anti-Camcording Act of 2010:

Section 3. Acts Constituting Unauthorized Possession, Use and/or Control of Audiovisual Recording Devices. - It shall be unlawful for any person, at a time when copyright subsists in a cinematographic film or other audiovisual work or its soundtrack and without the authorization of the copyright owner or exclusive licensee thereof, to:

(a)use or attempt to use an audiovisual recording device to transmit or make a copy of any performance in an exhibition facility of such cinematographic film or other audiovisual work or its soundtrack, or any part thereof;

(b)have in his/her possession, an audiovisual recording device in an exhibition facility, with the intent of using or attempts to use the audiovisual recording device to transmit or make a copy of any performance in the exhibition facility of such cinematographic film or other audiovisual work or its soundtrack, or any part thereof; or

(c)aid, abet or connive in the commission of the acts prohibited under this section.

Section 4. Penalties. - A person who will be found guilty of violating the provisions of Section 3 shall be subject to a fine of Fifty thousand pesos (Php50,000,00) but not exceeding Seven hundred fifty thousand pesos (Php750,000,00) and imprisonment of six (6) months and one (1) day to six (6) years and one (1) day.

The Exhibitors have no control of the audience in the case of online screening. Exhibitors should remind the viewers not to screenshot or record and upload any parts of the movie without our consent. Unauthorized recording, uploading and sharing of the film are not allowed.

6. Force Majeure.

If either party hereto is prevented in the performance of any act required hereunder by reason of act of God, fire, flood, or other natural disaster, malicious injury, strikes, lock-outs, or other labor troubles, riots, insurrection, war or other reason of like nature not the fault of the party in performing under this Agreement, the performance of such act shall be excused for the period of the delay and the period of the performance of any such act shall be extended for a period equivalent to the period of such delay except that if any delay exceeds six months, then the party entitled to such performance shall have the option to terminate this Agreement.

If a particular screening does not push through, EdukSine Productions Corporation and Exhibitors shall mutually agree to the next screening date, which should not be held more than 6 (SIX) months after the original screening date.

EDUKSINE PRODUCTIONS CORPORATION shall not be held liable in case any untoward incident, such as fire, earthquake or stampede, will happen during the screening that will result in the injury or death of attendees.

8. Miscellaneous.

This Agreement contains the entire agreement of the parties, and there are no other promises or conditions in any other agreement whether oral or written. This Agreement may only be amended in a writing signed by both parties. This agreement shall be governed by the laws of the Republic of the Philippines.
