SCOPE OF WORKS

- 1. Conduct site visits/ocular inspections for the building to be provided with Mechanical Plans and Fire Detection and Alarm Systems Plan.
- 2. Collection and Gathering of data as preparatory measures for making the Mechanical Plans and Fire Detection and Alarm Systems Plan.
- 3. Preparation of mechanical plans and FDAS in accordance with R.A. 9514 also known as the "Fire Code of the Philippines" and R.A. 6541 or the "National Building Code of the Philippines" especially the Rule 3, Section 302 indicating the provision of the "Detailed plans of fire suppression systems, location of automatic and smoke detectors and alarm and initiating devices used to monitor the conditions that are essential for the proper operation including switches for the position of gate valves as well as alert and evacuation signals; the detailed layout of the entire safe area to be protected and the heat/smoke ventilation system."
- 4. To check if the number of the installed firefighting equipment (fire extinguisher, smoke detector, cabinet hose, etc.) is in accordance with the standards of the Fire Code of the Philippines and check if the existing sprinkler system of the 3 Storey with Roof Deck Building is functioning well.
- Certification (signed and sealed) that the firefighting equipment is in conformity with the standards of the Fire Code of the Philippines and the existing sprinkler system is functioning properly must be provided.
- 6. To submit estimated cost for the actualization of the FDAS and mechanical plan.
